zlib Data Compression Library

zlib 1.2.3 is a general purpose data compression library. All the code is thread safe. The data format used by the zlib library is described by RFCs (Request for Comments) 1950 to 1952 in the files <http://www.ietf.org/rfc/rfc1950.txt> (zlib format), [rfc1951.txt](http://www.ietf.org/rfc/rfc1951.txt) (deflate format) and [rfc1952.txt](http://www.ietf.org/rfc/rfc1952.txt) (gzip format). These documents are also available in other formats from <ftp://ftp.uu.net/graphics/png/documents/zlib/zdoc-index.html>

All functions of the compression library are documented in the file `zlib.h` (volunteer to write man pages welcome, contact zlib@gzip.org). A usage example of the library is given in the file `example.c` which also tests that the library is working correctly. Another example is given in the file `minigzip.c`. The compression library itself is composed of all source files except `example.c` and `minigzip.c`.

To compile all files and run the test program, follow the instructions given at the top of `Makefile`. In short "make test; make install" should work for most machines. For Unix: `./configure; make test; make install`. For MSDOS, use one of the special makefiles such as `Makefile.msc`. For VMS, use `make_vms.com`.

Notes for some targets:

- For Windows DLL versions, please see win32/DLL_FAQ.txt
- For 64-bit Irix, deflate.c must be compiled without any optimization. With -O, one libpng test fails. The test works in 32 bit mode (with the -n32 compiler flag). The compiler bug has been reported to SGI.
- zlib doesn't work with gcc 2.6.3 on a DEC 3000/300LX under OSF/1 2.1 it works when compiled with cc.
- On Digital Unix 4.0D (formely OSF/1) on AlphaServer, the cc option -std1 is necessary to get gzprintf working correctly. This is done by configure.
- zlib doesn't work on HP-UX 9.05 with some versions of /bin/cc. It works with other compilers. Use "make test" to check your compiler.
- gzdopen is not supported on RISCOS, BEOS and by some Mac compilers.

This Addendum forms part of and incorporates by reference the Microsoft Development Technologies Master Agreement (the "Master Agreement") signed by Microsoft Corporation or its affiliate ("us") and "you," the entity signing below.

1. ENROLLMENT. After you sign and return this Addendum to us, we will notify you if we accept it. The effective date of this Addendum will be the date specified in our acceptance notice.

2. ADDITIONAL DEFINITIONS. In addition to the definitions in the Master Agreement, the following definitions apply:

2.1 "Eligible Products" means your software development tools and products that:

(a) are listed on Exhibit A; and

(b) run on one or more Microsoft Platforms; and

(c) use the compiler(s) contained in the SDK solely as an intermediate language (that is, the output of our compilers are then inputted into the build-tool portions of your Eligible Product to be further compiled into an executable that runs on a Microsoft Platform) and not, for example, directly to your end users for its standalone compiler purposes.

2.2 "SDK Files" means one or more of the Windows Software Development Kit .ISO files listed in Exhibit B, and any updates we provide you from time to time under this Addendum. SDK Files will be deemed "Software" and "Distributable Code" for purposes of the Master Agreement.

2.3 "Microsoft Platforms" means any current and future Microsoft operating system products, Microsoft run-time technologies (such as the .NET Framework), and Microsoft application platforms (such as Microsoft Office or Microsoft Dynamics) that we offer during the Term.

3.1 Delivery. We will deliver the SDK Files to you promptly after the effective date of this Addendum.

3.2 Specific License Rights. If you comply with Sections 4.2 and 4.3 of the Master Agreement and Section 4 below, then, in lieu of the rights granted in Sections 3.1 and 4.1 of the Master Agreement, your rights to the SDK Files are as follows:

Preamble

The licenses for most software are designed to take away your freedom to share and change it. (For example, a function in a library to compute square roots has a purpose that is entirely well-defined independent of the application. Therefore, Subsection 2d requires that any application-supplied function or table used by this function must be optional: if the application does not supply it, the square root function must still compute square roots.)

These requirements apply to the modified work as a whole. Preamble

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

The licenses for most software and other practical works are designed to take away your freedom to share and change the works.
