1. ENROLLMENT. After you sign and return this Addendum to us, we will notify you if we accept it. The effective date of this Addendum will be the date specified in our acceptance notice.

2. ADDITIONAL DEFINITIONS. In addition to the definitions in the Master Agreement, the following definitions apply:

2.1 "Eligible Products" means your software development tools and products that:

(a) are listed on Exhibit A; and

(b) run on one or more Microsoft Platforms; and

(c) use the compiler(s) contained in the SDK solely as an intermediate language (that is, the output of our compilers are then inputted into the build-tool portions of your Eligible Product to be further compiled into an executable that runs on a Microsoft Platform) and not, for example, directly to your end users for its standalone compiler purposes.

2.2 "SDK Files" means one or more of the Windows Software Development Kit .ISO files listed in Exhibit B, and any updates we provide you from time to time under this Addendum. SDK Files will be deemed "Software" and "Distributable Code" for purposes of the Master Agreement.

2.3 "Microsoft Platforms" means any current and future Microsoft operating system products, Microsoft run-time technologies (such as the .NET Framework), and Microsoft application platforms (such as Microsoft Office or Microsoft Dynamics) that we offer during the Term.

3. SOFTWARE TERMS.

3.1 Delivery. We will deliver the SDK Files to you promptly after the effective date of this Addendum.

3.2 Specific License Rights. If you comply with Sections 4.2 and 4.3 of the Master Agreement and Section 4 below, then, in lieu of the rights granted in Sections 3.1 and 4.1 of the Master Agreement, your rights to the SDK Files are as follows:

(a) You may copy and distribute, in conjunction with your Eligible Products, one or more of the SDK Files in their entirety (i.e., you may not distribute individual files contained within the SDK Files).

(b) For any pre-release versions of SDK Files, however, the license terms with those versions and Section 3.2 of the Master Agreement will apply.

States should not allow patents to restrict development and use of software on general-purpose computers, but in those that do, we wish to avoid the special danger that patents applied to a free program could make it effectively proprietary. To prevent this, the GPL assures that patents cannot be used to render the program non-free.

The precise terms and conditions for copying, distribution and modification follow.

0. Definitions.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

0. Additional Definitions.

As used herein, "this License" refers to version 3 of the GNU Lesser General Public License, and the "GNU GPL" refers to version 3 of the GNU General Public License.

"The Library" refers to a covered work governed by this License, other than an Application or a Combined Work as defined below.

An "Application" is any work that makes use of an interface provided by the Library, but which is not otherwise based on the Library. Defining a subclass of a class defined by the Library is deemed a mode of using an interface provided by the Library.

A "Combined Work" is a work produced by combining or linking an Application with the Library. The particular version of the Library with which the Combined Work was made is also called the "Linked Version".

The “Minimal Corresponding Source” for a Combined Work means the Corresponding Source for the Combined Work, excluding any source code for portions of the Combined Work that, considered in isolation, are based on the Application, and not on the Linked Version.

The “Corresponding Application Code” for a Combined Work means the object code and/or source code for the Application, including any data and utility programs needed for reproducing the Combined Work from the Application, but excluding the System Libraries of the Combined Work.

1. Exception to Section 3 of the GNU GPL.

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

The licenses for most software and other practical works are designed to take away your freedom to share and change the works. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change all versions of a program--to make sure it remains free software for all its users. We, the Free Software Foundation, use the GNU General Public License for most of our software; it applies also to any other work released this way by its authors. You can apply it to your programs, too.

When we speak of free software, we are referring to freedom, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for them if you wish), that you receive source code or can get it if you want it, that you can change the software or use pieces of it in new free programs, and that you know you can do these things.

To protect your rights, we need to prevent others from denying you these rights or asking you to surrender the rights. Therefore, you have certain

responsibilities if you distribute copies of the software, or if you modify it: responsibilities to respect the freedom of others.

TERMS AND CONDITIONS

0. Definitions.

"This License" refers to version 3 of the GNU General Public License.

"Copyright" also means copyright-like laws that apply to other kinds of works, such as semiconductor masks.

"The Program" refers to any copyrightable work licensed under this License. Each licensee is addressed as "you". "Licensees" and "recipients" may be individuals or organizations.

To "modify" a work means to copy from or adapt all or part of the work in a fashion requiring copyright permission, other than the making of an exact copy.

The resulting work is called a “modified version” of the earlier work or a work “based on” the earlier work.

A “covered work” means either the unmodified Program or a work based on the Program.

To “propagate” a work means to do anything with it that, without permission, would make you directly or secondarily liable for infringement under applicable copyright law, except executing it on a computer or modifying a private copy.
